Gleneagles Secondary College is looking forward to another great year of teaching and learning and would like to advise you of the parent payment arrangements for 2021.

Please find the fee schedule for year 10 attached.

Gleneagles Secondary College makes every effort to keep the cost of items and activities to a minimum and affordable for all parents.

A majority of College Council are parent representatives and the Council carefully considers the needs of our community. The College Council seeks to ensure the fees are reasonable while ensuring we can provide excellent education opportunities for our students supported by varied programs, excellent equipment and well maintained facilities. The Gleneagles College Council unanimously adopted the Parent Payment Policy, the 2021 Essential Items and Optional Items levies for each year level. The Council endorsed the suggested voluntary donation amounts.

Financial Support for Families

Gleneagles understands that some families may experience financial difficulty and offers a range of support options, including:

- **Health Care Card (HCC)** – Parents who are holders of an eligible healthcare card or pension card, valid on 28 January, 2021 can apply for CSEF. To enable us to process your application please come into the school before 11 December, 2020 or from 22 January to 28 February, 2021.
- **State School Relief** – limited support may be available for families in need of uniform items.

- **Camps and Sporting Events Funds (CSEF)** – Families holding a valid:
 - Means tested concession card
 - Temporary foster parents are eligible to apply.
 - Bridging visa, temporary protection visa
 - Community detention or asylum seekers
 - Students in out of home care
 - Students in statutory kinship careEligibility dates:
Term 1 – 28 January, 2021
Term 2 – 19 April, 2021
